

## **Petition for Name Change**

-Petitions for name changes are currently being heard in Courtroom #6 on Monday, Tuesday and Thursday mornings promptly at 8:45 AM. Late petitions will not be heard. This is open motions court, so appointments are not needed.

-There will be a filing fee to be paid in the Prothonotary's office immediately after motions court. This is payable by cash or check only. The fee may be waived if certain income guidelines are met. See the librarian for more details on the In Forma Pauperis petition.

-Petitions for a judicial name change may carry the requirement of advertising in the local newspaper and the local legal journal (administered by the Beaver County Bar Association.) These fees are approximately \$75-150 each and CANNOT be waived.

-No court staff may give legal advice. If you have any questions, you may contact the Lawyer Referral Service at 724-728-4888.
