This emergency information was developed by the Beaver County Emergency Management Agency with the support of the Pennsylvania Emergency Management Agency, and in accordance with state law and federal regulations. This important information was placed in the telephone directory by FirstEnergy Corporation, in cooperation with your county government.

Dear Beaver County Resident/Visitor:

This section contains general information and specific instructions on what you may be asked to do should a serious incident occur at the nuclear facility, Beaver Valley Power Station. This information is updated annually.

The protective actions identified in this section represent specific procedures contained in and supported by state, county and municipal plans. These plans were developed to provide a coordinated public response to an emergency. It is important that you respond quickly but calmly when notified that protective actions are to be taken.

How Will You Learn of a Serious Nuclear Incident?

If there is significant information that could affect your safety, or if protective actions are required to protect your health and safety, the standard "Alert Signal" will be sounded over the siren system that has been installed within an approximate 10-mile radius of Beaver Valley Power Station. This signal is a steady three-minute signal - not a wailing or warbling signal. If the Alert Signal is sounded in your community, tune your radio or TV to one of the County Emergency Alert Stations. A message will be broadcast advising you what action should be taken. Municipal police and firefighters may conduct neighborhood notification using mobile public address systems or door-to-door notification as a supplement to the siren system.

Don't use the telephone to try to get emergency information. That seldom will bring results and could tie up lines urgently needed for emergency operations aimed at your protection.

If you have a neighbor who is hard of hearing or physically disabled, please check to ensure that this neighbor has received the alert and understands what to do.

Potassium Iodide (KI)

The use of potassium iodide (KI) is an additional protective action.

State and local officials will announce when the public should take KI in Emergency Alert System messages. KI is a nonprescription medication that blocks the uptake of radioactive iodine by the thyroid gland. KI does not protect a person or the thyroid from direct exposure to radiation. Taking KI only saturates the thyroid with nonradioactive iodide. For most individuals, taking KI is safe; however, adverse reactions are possible in

persons having existing thyroid conditions and those with an allergy to iodine. Consult your physician if you have concerns about the safety of KI for your child or yourself. Follow the directions for storage and use that were included with the product. Residents living within the 10-mile radius, who have not already done so, may obtain more information about KI or obtain KI by contacting:

If You Are Told to Take Shelter

Should you be directed to take shelter (remain indoors), there will be several things you need to do:

- Close all windows and outside doors.
- Shut all vents; turn off air conditioning units and/or turn down heaters. Continue to listen to the EAS radio/TV stations for further instructions.
- Bring pets indoors; shelter farm animals to extent possible.
- Remain inside until you are told it's safe to go out.
- Don't use telephone, leave lines open for emergencies. Those not at home should take the best available shelter.

Stay indoors until you receive official notice that it is safe to go out. Special arrangements will be made by state, county and municipal officials to take care of school children and hospital patients.

Farm Animals

Farmers affected by a Take Shelter or Evacuation advisory should shelter their animals and monitor their EAS radio or TV stations for instructions and information.

Refer to the farmers' emergency information brochure or contact your county agricultural agent.

Evacuation Information

If it is necessary to evacuate an area, you will be informed by an announcement on your EAS Station. The message will include any special instructions (including potassium iodide (KI) information) which might be called for by the particular situation. The message will be updated periodically.

Special arrangements will be made to take care of the sick and the disabled.

If You Are Told to Evacuate

If you are advised to evacuate, follow instructions promptly and carefully. The map in this section identifies main evacuation routes. Also see the "Where to Go" column which describes, by municipality, where you should go for temporary accommodations and the highways to use.

School students will be relocated to identified host schools or facilities. See the "School Information" column for specific information.

When instructed to leave, secure your home as you would for a trip.

What To Take With You

You should plan to spend a minimum of three days away from home. Bring only essential items and avoid excess baggage. Take only what you need and then in small quantities.

Suggested Items to Take:

- Clothing appropriate for the season
- Extra undergarments/sleepwear
- Prescription/patent medicines, soap & towels/ toothbrush & toothpaste
 - Flashlight & batteries
 - Shaving articles/sanitary devices
 - Credit cards/checkbooks
 - Portable radio & batteries
 - First Aid Kit
 - Baby supplies/small toys
 - Special Medical Equipment (walkers, wheelchairs,etc.)

For sanitary reasons, pets will not be permitted in reception centers and mass-care centers. You are responsible for their care. Guidedogs for the handicapped will be allowed inside mass care centers.

If You Need Transportation

If you are instructed to evacuate and you do not have transportation, attempt to obtain a ride with neighbors, a friend, or a relative who lives nearby.

If this is not possible, go to the transportation pick-up point listed for your municipality (see "Where to Go?"). Special needs cards are mailed to your residence each year. If you need special assistance in the event of an emergency, please fill this card out each year and mail it back. Your card will be kept on file and will be used to notify you if evacuation is required.

EXAMPLE

School Information School Information

Parents of children attending school within the Emergency Planning Zone are urged NOT to call or go to the schools when protective action recommendations, such as sheltering or evacuation, have been issued. This would only add confusion and could hinder school authorities from the special provisions that have been made to protect your children.

If school is in session at the time evacuation is recommended, children attending schools located within the Emergency Planning Zone will be transported by bus to designated host facilities outside the area. They will remain there under school supervision until picked up by parents or guardians. These student pick-up points have been planned to coincide with main evacuation routes.

Students whose homes are inside but who attend school outside the Emergency Planning Zone will not be sent home if an evacuation is advised. They will remain at the school they attend under school supervision until picked up by parents or guardians.

Specific information concerning student pick-up points (see "Where TO GO") will be provided to parents by school officials. If your child's school is subject to evacuation and you are not aware of the designated pick-up point, contact the school principal or school district superintendent.

Day Care Information

Parents and guardians with children at day care facilities within the emergency planning zone should become familiar with the facility's emergency plans. Contact the day care facility operators for more information.

How Are Incidents Classified

Should an incident occur at the Beaver Valley Power Station, there are four incident classifications you might hear reported on radio, TV or read in the newspapers. So that you will understand their meaning, they are explained in the order of their potential seriousness.

Unusual Event

Events within this classification meet the following definition:

Events are in process or have occurred which indicate a potential degradation of the level of safety of the plant or indicate a security threat to facility protection has been initiated. No releases of radioactive material requiring offsite response or monitoring are expected unless further degradation of safety systems occurs.

Such events characterize abnormal plant conditions which, by themselves, do not constitute significant emergency conditions, but are considered to be potential precursors to more severe conditions. In this use, a precursor is a condition that could, if appropriate action were not taken, escalate to a more severe condition. The purpose of this classification is to ensure that the plant operating staff, takes appropriate action for the initiating condition, such as assessment and verification, and comes to a state of readiness to respond in the event that the condition becomes more severe. Offsite authorities are notified of this classification within 15 minutes, however, with the possible assistance by local support groups such as fire companies or medical facilities, no offsite response is expected.

Alert

Events within this classification meet the following definition:

Events are in process or have occurred which involve an actual or potential substantial degradation of the level of safety of the plant or a security event that involves probable life threatening risk to site personnel or damage to site equipment because of hostile action. Any releases are expected to be limited to small fractions of the EPA protective action guideline exposure levels. Such events characterize plant conditions that warrant activation of the site emergency response organization and augmentation of onsite emergency resources.

The purpose of this classification is to ensure that the plant operating staff takes appropriate action for the initiating condition, such asassessment and verification, and activates the emergency response organization. Offsite authorities are notified of this classification within 15 minutes. Some offsite agencies may place their respective emergency organizations on standby.

What Is Radiation

Nuclear radiation consists of energy in the form of invisible particles or rays given off by radioactive materials. Small amounts of radioactive material exist naturally and always have been part of mankind's environment. Radioactive materials in varying amounts are present in the earth's crust, the sun's rays,

the air we breathe, the food we eat and the water we drink. As a result, every person has radioactive materials within his body. Larger amounts of radioactive materials are produced by and contained within a nuclear

power plant. Mankind's use of radioactive materials also results in radiation exposure. For example doctors and scientists have used X-rays in medical treatment for many years. The amount of radiation a person receives is measured in terms of radiation dose. The unit to measure this dose is called a millirem.

The following table shows examples of typical radiation doses to sensitive tissue due to natural radioactive materials or mankind's use of radioactive materials:

Site Area Emergency Site Area Emergency

Events within this classification meet the following definition: Events are in process or have occurred which involve an actual or likely major failures of plant functions needed for the protection of the public or hostile action that results in intentional damage or malicious acts:

(1) toward site personnel or equipment that could lead to the likely failure of or; (2) prevents effective access to equipment needed for the protection of the public. Any releases are NOT expected to result in exposure levels which exceed EPA protective action guideline exposure levels outside the Exclusion Area Boundary

Such events characterize plant conditions that warrant activation of the site emergency response organization, augmentation of onsite emergency resources, and constitute the lowest level where offsite emergency response may be necessary. Offsite emergency response organizations activate in anticipation of the need to implement offsite protective actions should the condition degrade.

General Emergency

Events within this classification meet the following definition:

Events are in process or have occurred which involve actual or imminent substantial core degradation or melting with potential for loss of containment integrity or hostile action that results in an actual loss of physical control of the facility. Releases can be reasonably expected to exceed EPA protective action guidelines exposure levels outside the Exclusion Area Boundary

At this classification, total activation of the onsite and offsite emergency response organizations is required. The onsite organization shall recommend offsite protective actions to designated offsite agencies. These offsite organizations, following evaluation of the onsite recommendation, will implement appropriate offsite protective actions.
